2023-24 School Description and Mission Statement

Principal's Message

Village High School, which opened in 1978, serves as a "new beginning" for students in the Pleasanton Unified School District. Village offers a small and caring climate that supports student success and creates a desire for continued success. Students thrive in an environment that provides individual attention and instruction, consistency in behavioral and academic expectations, and support for each student and their unique personal needs. Village High School received the maximum sixyear term on the recent accreditation review by the Western Association of Schools and Colleges in March of 2019. The campus is home to approximately 100 students who are engaged in meeting district graduation standards, as well as exploring career interests and focusing on future goals. Instruction is geared to maximize the learning experience for each student, and, with a class size average of 15 to 1, teachers can support student learning throughout the curriculum. Partnerships and career education are also an important focus at Village, as staff, parents, and students work together to achieve common goals. Village High has several programs designed to create engaged learners and provide hands-on learning experiences. The pillars of the district's character education program are embedded in both the curriculum and day-to-day activities of Village High School. Overall, academic achievement, technology as a tool for learning, character building, and career exploration are all part of the Village High School experience. Students come to Village for a variety of reasons, but they leave with a healthy respect for themselves, the staff, and the community in which they live. The student body and staff work together to continue to create a model school environment that supports student success.

2023-24 School Description and Mission Statement

Founding

Village High School was opened in 1978 and has served as a "new beginning" for students in Pleasanton Unified School District as an educational option. Our school has been under the leadership of Principal Heather Pereira since 2020. We have a passionate group of certificated and classified staff who ensure our students receive the best education and learning experience possible. Being an alternative/continuation school in such a high-achieving district does provide its challenges, but we continue to rely heavily on our strong word-of-mouth reputation with students, staff, and parents to maintain our positive standing in the community.

Pleasanton Community

In Pleasanton, we have a population estimated at 78,252 residents. The average household income is \$160,689 with an average home price of over \$1,000,000 (city-data.com). There are many community groups and organizations such as Pleasanton Partnerships in Education, the Pleasanton Rotary, East Bay Youth Empowerment Group, Pleasanton Schools Excellence in Education Foundation, Pleasanton Cultural Arts Commission, and others that help Village to recognize and reward the students for their outstanding achievements. Even though Pleasanton is an affluent suburban community, there is still a significant population of students whose families are in economic distress. In the 2020-21 school year, it was estimated that 18% of our students at Village qualified for free or reduced lunch. While Pleasanton's community does have a thriving average household income, every staff member at Village is aware of and sensitive toward this significant percentage of our population.

Census Data

According to the 2020 Census, Pleasanton's largest growing ethnic population is Asian - growing to 34.4% from 11.7% in 2000. Pleasanton's residents are primarily White making up 56.03% of the population. The third-largest ethnicity is "Hispanic or Latino" making up 10.3% of Pleasantonians. Age, Sex, Household Size, and Level of Education have all only shifted a few percentages from 2000 to 2021.

Staff Description

Certificated Staff

Village has a very qualified group of certificated employees. Of the 16 certificated employees, all are appropriately certificated in their current positions. Of our certificated employees, 81% are male and 19% female. The ethnic breakdown of the staff is as follows: White (78%), Hispanic (6%), and Japanese (6%).

Classified Staff

Village has a very qualified group of classified employees. Of the 16 classified employees, all are appropriately placed in their current positions. Of our classified employees, 81% are female and 19% are male. The ethnic breakdown of the staff is as follows: White (62%), Chinese (8%), Filipino (8%), Asian Indian (8%), African American (8%), and "Declined to State Race" (8%).

2023-24 Quality, Currency, Availability of Textbooks and Other Instructional Materials

Instructional Materials

All textbooks used in the core curriculum at Village High School are currently being aligned to the California State Standards. Standards-based instructional materials are approved by the district's Board of Trustees. The district follows the State Board of Education's six-year adoption cycle for core content materials and the eight-year cycle for textbook adoptions in foreign language, visual and performing arts, and health.

On Tuesday, September 22, 2023, the Pleasanton Unified School District's Board of Trustees held a public hearing to certify the extent to which textbooks and instructional materials have been provided to students. The Board of Trustees adopted Resolution 2022-2023.09 which certifies as required by Education Code §60119 (1) that textbooks and instructional materials were provided to all students, including English learners, in the district to the extent that each pupil has a textbook or instructional materials, or both, to use in class and to take home, (2) sufficient textbooks and instructional materials were provided to each student, including English learners, that are aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks in math, science, history-social science, and English/language arts, (3) sufficient textbooks or instructional materials were provided to each pupil enrolled in foreign language or health classes, and (4) sufficient laboratory science equipment was available for science laboratory classes offered in grades 9-12 inclusive.

In addition to core subject areas, districts are required to disclose in their SARCs the sufficiency of instructional materials used for their visual/performing arts curricula. During the 2022-23 school year, Pleasanton Unified School District provided each student, including English learners, enrolled in a visual/performing arts class with a textbook or instructional materials to use in class and to take home. These materials complied with the state's content standards and curriculum frameworks.

School Facility Conditions and Planned Improvements

School Facilities & Maintenance

The district makes great efforts to ensure that all schools are clean, safe, and functional through proper facility maintenance and campus supervision. Village High School's original facilities were built in 1955; ongoing maintenance and campus improvements ensure facilities remain up to date and provide adequate space for students and staff. District maintenance and site custodial staff ensure that the repairs necessary to keep the school in good condition are completed promptly. A work order process is used by school and district staff to communicate non-routine maintenance requests.

Every morning before school begins, the administrator inspects facilities for safety hazards or other conditions that need attention before students and staff entering school grounds. One day custodian and one evening custodian are assigned to Village High School. The day custodian is responsible for:

- · Classroom cleaning
- Cafeteria setup/cleanup
- Groundskeeping
- Office area cleaning
- Restroom cleaning

Restrooms are checked throughout the day for cleanliness and subsequently cleaned as needed. The evening custodian is responsible for:

- · Office area cleaning
- Restroom cleaning

The principal communicates with custodial staff daily concerning maintenance and school safety issues.

Deferred Maintenance

Village High School participates in the State School Deferred Maintenance Program, which provides dollar-for-dollar matching funds to assist school districts with major repairs or replacement of existing school building components. Deferred maintenance projects generally include roofing, plumbing, heating, air conditioning, electrical systems, interior/exterior painting, and floor systems.

Facilities Inspection

The district's maintenance department inspects Village High School on an annual basis in accordance with Education Code §17592.72(c)(1). Village High School uses a school site inspection survey to identify unsafe or hazardous conditions and facility improvement needs. Some repairs were needed, a bathroom needed to be reconfigured to support students with special needs and no unsafe conditions were found. During fiscal year 2020-2021, all restrooms were fully functional and available for student use.

Bond Pass, Future Facilities

With the recent bond passing, Village and Educational Options will eventually get new facilities in the current campus footprint. This will update our school as well as provide students with additional resources.

2022-23 Career Technical Education Programs

College & Career Readiness

Students in grades ten through twelve receive counseling from school personnel regarding career paths and courses of study. The counselor meets at least once a year with each student to follow-up on their progress in meeting graduation requirements and career objectives. All career and technical education (CTE) courses comply with state-adopted content standards and are integrated into the student's four-year academic plan as elective courses. Village High School offers the following programs that promote leadership, develop job-related skills, provide on-the-job experience, and increase interest in school:

- Work Experience
- Regional Occupational Programs
- Career Technical Site Offerings: Culinary Arts and Skills, Farm to Fork, Catering

Individual student assessment of work readiness skills takes place through:

- End of course exams
- Completion of course-required projects
- On-the-job observation
- Classroom observation

Work experience students are partnered with local employers that provide on-the-job training and mentoring for students 16 years of age or older. Work experience students receive guidance and supervision designed to ensure maximum educational benefit from part-time job placement. For more information, students should contact the counselor.

Decisions concerning the selection of staff development activities are made by all staff using tools such as teacher input, district benchmark results, and data analysis to determine the areas in which additional teacher training may enhance classroom instruction and increase student achievement levels. Village High School supports ongoing professional growth throughout the year on minimum days. Teachers meet in both grade-level and department-level teams to conduct data analysis to identify areas of need. The teaching staff is provided the opportunity to participate in district-sponsored staff development workshops or training sessions as 1) a supplement to site-based staff development, 2) for reinforcement of or follow-up on previous training, or 3) follow-up training for newly implemented programs/curricula.

Village High School offers support to new and veteran teachers through peer coaching and mentoring. Instructional aides are provided with targeted training focused on teaching strategies and curriculum content. Substitute teachers are invited to participate in designated staff development activities. All staff members are encouraged to attend professional workshops and conferences. Classified support staff receives job-related training from department supervisors and district representatives.
